

Wheat and Cover Crop Enrollment Questions

Purpose

How did you hear about this program?	ADM and KACD would like to know how farmers heard about the program to see which marketing efforts or what employees are driving farmers to the program
Will a Farm Manager be managing this program?	FBN needs to talk to the person who knows what practices are being done at a field level basis
Farm Manager Name:	FBN needs to talk to the person who knows what practices are being done at a field level basis
Farm Manager Phone Number:	FBN needs to talk to the person who knows what practices are being done at a field level basis
Are you an ADM customer?	Defined as purchased from or sold to ADM within the last 3 years. We ask this to determine eligibility for wheat related payments
Who is your ADM contact?	ADM wants to ensure that farmers are talking to the right person within ADM to best serve their needs
What ADM Facilities do you deliver to?	Determines eligibility for programs
How many acres of corn do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of soybeans do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of wheat do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of peanuts do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of canola do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of sorghum do you farm?	Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres of cover crops (intended or planted) would you like to enroll	This question is asking about a true cover crop that is not harvested. Only asked to determine and ensure payments are accurate as all payments are done on a practice per acre basis. ADM and FBN aren't using this data for any other purpose
How many acres do you double crop on?	A payment for double crop practice after wheat is available, this question will determine eligibility and ensure max payment for the farmer
How many acres of no-till would you like to enroll?	A payment for no-till or strip till practices is available on wheat acres, this question will determine eligibility and ensure max payment for the farmer
What year did you first plant no-till wheat or sorghum?	ADM is determining how long farmers have been practicing no-till as there is a potential opportunity to market this to downstream customers, and ultimately bring this value back to the farmer
Are you interested in enrolling in the "Nitrogen Balance Safe Zone?"	Standard answer on this should be YES as it's an additional wheat payment that the farmer can qualify for with low time requirement on data collection
Would you like to enroll in the USDA Climate Smart Cover Crop program?	If a farmer is NOT in EQIP or other federally funded program, they have an opportunity for a higher cover crop payment if they answer YES. FSA documents and FSA subsidiary print will be requested and shared with NRCS/USDA
What year did you first plant cover crops?	If the farmer selects YES in the above question, this question will help determine which higher level of payment the farmer qualifies for.
Do you currently have acres enrolled in an EQIP/CSP program?	Confirms eligibility for USDA Climate Smart Cover Crop Program, this will flag FBN to make sure farmer is getting max payment.
Do you wish to enroll as a NBGC Leader?	This question is for those who are interested in being part of the National Black Growers Council
Would you like a split payment across multiple entities?	This lets ADM know right up front if we need to set up additional accounts to ensure fast and accurate payment.
Are you currently enrolled in another private sustainability program?	If the farmer selects YES, this does NOT kick them out of the program, merely ensures that the FBN rep gets all acres that farmer is eligible for into the correct program.
