

# SUSTAINABILITY ENROLLMENT PROCESS

FBN's sustainability enrollment tool is designed to offer farmers an easy experience to enroll and sign sustainability contracts through the FBN app

#### This tool offers farmers:

- **Faster payment** by connecting their FBN account with their ADM account at time of enrollment
- **Faster enrollment** by making enrollment and contract signing one seamless experience

## Steps to enroll:

- 1. Talk to farmer about program
  - a. Same process as last year!
  - b. If farmer is interested, send them a link via text/email or have them scan a QR code





## Frequently Asked Questions:

- Can I enroll farmers and just send them a contract to sign?
  - The enrollment questions/contract signing is easy. The hard part is signing in! Best practice will be for you to walk farmers through this process over the phone
  - We are working on a process where TAs can request a contract for a farmer, which will send the farmer an email that logs them in and takes them right to the enrollment questions
- How do I see what farmers have signed contracts?
  - We will have a shared gSheet or similar report that will show you the status of all farmers that have started the enrollment process
- How do farmers re-enroll?
  - They follow the same process as new farmers
  - We are working to develop an email process to mass invite last year's customers to re-enroll
